

Please observe the following conditions to ensure ALL patrons have an enjoyable stay at BIG4 Albury Tourist Park

PARK CONDITIONS

- **SPEED LIMIT:** Vehicles must not exceed 5km/h (walking pace) within the park grounds. Please be aware of pedestrians and bike riders (particularly children) at all times.
- **NOISE:** It is requested that all noise in the park ceases by 10.00pm. Any person(s) disturbing the peaceful enjoyment of other guests in the park or making excessive noise, may be requested to vacate the park.
- **ARRIVAL & DEPARTURE:** Check in time from 2.00pm, check out by 10.00 am unless otherwise arranged with management.
- **CHILDREN:** It is the parents or guardians responsibility to ensure that children understand and comply with all park rules. All children must be accompanied to the amenities by a person of a responsible age. It is the parents or guardians responsibility to ensure safe supervision of children when using the playground facilities and to ensure appropriate behaviour when using all other communal facilities.
- **AMENITIES, LAUNDRY & CAMP KITCHEN:** Please note that all communal facilities are Non-Smoking. Please ensure that facilities are used for their intended purpose and are left in a clean and tidy condition after use.
- **VISITORS:** All visitors must report to reception when entering the park. Day visitors are not permitted to bring cars into the park unless management has given prior approval. Site holders are fully responsible for ensuring appropriate behaviour of visitors and ALL VISITORS must vacate the park by 10pm sharp.
- **GARBAGE / RECYCLING:** Please note all domestic garbage is to be wrapped in plastic bags and placed in the green lidded bins. Please read the label on the yellow lidded bins for items that are to be recycled.
- **BIKES:** Bikes, scooters etc are not permitted after dark. Helmets must be worn at all times by all persons.

Management reserves the right to request any patron to withdraw from the park at any time if in the opinion of the managers, a patron's conduct is not deemed to be appropriate and in accordance with the above conditions.

EMERGENCY MANAGEMENT PLAN

In the case of an EMERGENCY you should: (when directed by Emergency Services and/or management)

- Secure your valuables
- Turn off power and gas to your site
- Close all windows, doors and hatches
- Gather your family
- Walk to the playground area illustrated on map
